RESPONSE TO REQUEST FOR PRODUCTION AND
SUPPLEMENTAL REQUEST FOR PRODUCTION

TO: Defendant, Remington Arms Company, Inc., and its attorney
in charge, J. Robert McKissick, KLEBERG, DYER, REDFORD &
WEIL, Post Office Box 2446, Corpus Christi, Texas 78403.

In accordance with the appropriate rule of civil procedure,
your Plaintiff in this case requests this Court to protect the
Plaintiff and his cause of action by restricting the production
requested by the Defendant, and would show the Court as follows:

I.

In its request and supplemental request for production, the
Defendant is asking the Court to order the Plaintiff to deliver
the rifle involved, as well as live ammunition, spent cartridges,
etc. for inspection and testing at the office of the undersigned
attorney, on October 24, 1980 at 10:00 o'clock in the morning,
at which time said items are to be released to Defendant and its
attorney for inspection, non-destructive testing, and/or copying
at Defendant's expense, to be returned to the Plaintiff's
attorney within thirty days.

II.

Your Plaintiff will show he has no objection to the produc-
tion as requested, but is concerned about the damages to the
cause of action in the event such items are lost, destroyed or
damaged. Accordingly, your Plaintiff asks this Court to require
the Defendants to post a bond payable to the Plaintiffs in an
amount sufficient to compensate the Plaintiff for all his
damages in the event such items are lost, damaged or destroyed;
that in the event the items are lost, damaged or destroyed,

the Defendant in no way be allowed to utilize any of its findings in the trial of this cause or contest the findings of the Plaintiff, or that the Court enter some other order that will fully protect the Plaintiff in the premises.


