COMPARISON OF MODEL 721, 722, 725 AND 700

TRIGGER ASSEMBLIES

The Models 721, 722 and 725 were discontinued in 1962, with the introduction of the Model 700 that same year.

The Model 721 and 722 rifles use the same trigger assemblies.

The trigger assembly for the Model 725 rifle used many of the parts used in the Model 721 and 722 rifles.

The trigger assembly for the Model 700 uses five parts from the Model 721, 722 and 725. The accompanying chart lists the trigger assembly parts. It also shows which parts are interchangeable, and which parts are not interchangeable.
