ORDER

THIS CAUSE coming on to be heard in the trial of the cause and it being represented unto the court by the defendant, JOSEF OFFENWANGER, by his attorney that there is a settlement offer in the amount of \$600,000.00 being presented to the attorney for the plaintiffs as a full and final settlement of all claims by the plaintiffs against the said defendant JOSEF OFFENWANGER on condition that this court determine that said offer is an "offer made in good faith" pursuant to the statutes provided therefor and that said settlement will also effect a dismissal of all other claims against the said defendant JOSEF OFFENWANGER including claims of the co-defendant REMINGTON ARMS COMPANY, INC., set forth more particularly in the counterclaim filed herein, all parties to the lawsuit being present in open court and the court being fully advised in the above premises,

IT IS HEREBY ORDERED that:

1. This court finds that the offer of the defendant JOSEF OFFENWANGER to settle all claims of the plaintiffs, BARBARA SEYFERTH, for herself, as Executor of the Estate of DIETER SEYFERTH, and as Representative and Next Friend of her minor child, NORBERT SEYFERTH, and DIETER SEYFERTH, JR., and GERHARD SEYFERTH, for and in return of a payment of \$600,000.00 be and hereby is determined to be a "good faith settlement" pursuant to the statutes of the State of Illinois herein provided and that said settlement does effect a total and complete settlement of all claims by the plaintiff against the defendant JOSEF OFFENWANGER and all other claims against JOSEF OFFENWANGER including the counterclaim of REMINGTON ARMS COMPANY, INC. against JOSEF OFFENWANGER and that the said plaintiff is hereby given authority to execute necessary release and acquittance papers to effect said settlement subject to the further order of this court and/or the Probate Division of the Circuit Court of Cook County pursuant to local rule.

2. That the above cause entitled BARBARA SEYFERTH, for herself, as Executor of the Estate of DIETER SEYFERTH, and as Representative and Next Friend of her minor child, NORBERT SEYFERTH, and DIETER SEYFERTH, JR., and GERHARD SEYFERTH, v. JOSEF OFFENWANGER be and hereby is dismissed with prejudice and with no costs.
