

This meeting was called to discuss the current Amerit system used by Ilicon in checking guns for safety and non-safety related defects. After discussion it was determined that the point system used was appropriate and realistic, but that better use could be made of the data generated from the quality audits. At least once a quarter E.C. Larson and L.L. Frennell will review the Ilicon quality audit data with Ilicon Design, in order to determine whether there is indication of latent safety problems. C.B. Workman will now report safety related problems to the Operations Committee separate and apart from his report on non-safety related problems, so as to highlight the areas of real concern. The Product Safety Subcommittee is to be immediately notified whenever warehouse product is held for any reason related to safety.
