To Whom It May Concern:

Enclosed please find the Remington 700 Sendero 300 Win Mag that I purchased last year. I ordered the gun in July and didn't get it until December, after our deer season had past here in Missouri.

I was not completely satisfied with the accuracy I was getting from the gun so my brother-in-law recommended I get the trigger lightened. A gunsmith in Ruston, LA lightened the trigger to about 2.5 pounds, which seemed to help.

During this deer season while I was hunting, I saw a deer and flipped the safety to the fire position. The gun immediately discharged! I was able to bolt the gun and shoot the deer as well as another one which came after it. After I got down from the tree stand, I unloaded the gun and adjusted the safety to the safe position. When I flipped it to the fire position, it dry fired. I did this probably ten times in a row and every time the gun would dry fire.

I spoke to your Customer Service department today, and they suggested that I send it to you. I am asking that you do the following:

- 1) Assess what is wrong with the trigger mechanism of the gun.
- 2) Notify me of the results of your investigation at the following contact information: Work 314-234-0137, Home 636-433-2580, E-mail douglas.g.engemann@boeing.com
- 3) Provide me an estimate of the cost of putting in a new X-Mark Pro Trigger. Please note that if I decide to put in the X-Mark Pro Trigger, I would want it lightened to the minimum of factory specifications.

Please advise me of your findings as soon as you can and thank you for your attention in this matter.
