They both worked real good until the season of 06. I was elk hunting at -20 degrees and found some elk bedded down. I took the safety off and pulled the trigger. It would not pull. I put the safety back on. When I took it off again, the gun fired. I tried the same procedure again. It fired again when I took the safety off. I did not think too much of it seeing it was 20 below. I just thought it was frozen up. That was the stainless steel one.

Then in 07 season, my grandson used my wife's blued one for deer hunting. We found a deer standing unaware of us. I told him to shoot it. He took the safety off and tried to shoot it, but could not pull the trigger. He put the safety back on and when he put it off again, the gun went off.

This time the temperature was 47 above. It scared me to have a gun go off for my grandson.

I have had many Remington rifles in my life. These were the first two to give me any troubles. Has there been any recalls or anything on the model sevens?


