I am sending my rifle for replacement of the safety. During my deer hunt in November 2008, at the completion of a hunting day without any having an opportunity at a shot, I moved the safety from Safe to Fire in order to unload the rifle. When I pushed the safety to fire, the gun discharged. I had previously used the gun for elk hunting about two weeks prior without any problems. It is my understanding that the cost for the replacement under the recall listed on your web site is \$20.00. To my knowledge, no prior work has been done on the gun. I purchased it used from a dealer.

It is my understanding that you may send the gun to a dealer to effect the repairs. If that is the case, I would like to get an estimate for adjusting the trigger to a 3 to 3 1/2 pound pull, if that is possible. I would also like to get an estimate for replacement of the recoil pad to a limbsaver pad or a pad similar to that installed on the Remington 700 XCR in 375 that I recently purchased.
