Keith,

As per our previous conversations, here is how the rifle malfunctioned. My wife was shooting it at the range in preparation for a moose hunt, so I was coaching her and giving her instructions. She had ejected a spent shell casing and before closing the bolt, she put the safety in the "safe" position. No, I didn't tell her to do this! Anyway, she proceeded to close the bolt, putting a live round in the chamber. I didn't think the bolt would allow this to happen, so I never gave it another thought. When she was ready to shoot, she nudged the safety forward into the "fire" position, and the gun fired! Her thumb was all that was touching the gun as the rest of her hand was out to the side. I taught her to do this so her finger would never be on the trigger when the safety was put in the "fire" position. I was watching her the entire time, so I can verify that this is exactly what happened. I tried to duplicate this action several times, with an empty chamber, but was never able to do so.

When you and I discussed this, you thought it might be the fault of the "locking bolt". I would really appreciate you replacing this bolt with the old style bolt that doesn't have this goofy feature. Also, could you please test the trigger to see what the pull weight is and if it is over four pounds, could you please adjust it to four pounds?
