I want you to know I do not believe for one minute that this gun has been altered but I had already heard this was what Remington would say. After discussing this issue again with my grandson who experienced the malfunction I was not clear in my explanation of the malfunction when I sent the rifle in to Remington. He fired the gun and put another shell in chamber with the safety off, when he tryed to fire again the trigger would not pull, so with the safety on he ejected the shell, reloaded, and when he took the safety off the rifle fired, this happened twice.

I have always been a Remington and 700 fan, have two other 700's besides this one and have owned others but if this is the way Remington chooses to treat their customer I will think long and hard before purchasing another Remington product. How do you explain the developer of this trigger assembly stating on national TV that it is flawed? Rest assured I don't expect a postive answer just more of the same laying the blame on the customer.


