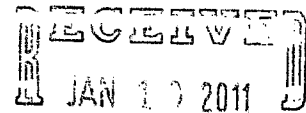

Then I did the same procedure two more times and it did the same thing. The next four rounds when I chambered the round the gun fired without pulling the trigger or moving the safety. Then I came home and just cocked the empty gun and pushed the bolt down and it fired. Then I did two more times and it did the same thing.

I'm 63 years old, I've been trained in the United States Army, I've hunted since I was 8 years old so I don't want any garbage about not being experienced on handling guns. I also helped train students for hunter safety courses.

This is my 30-06, will my 300 Mag. do the same thing? They are both 700s.
I now refuse to use the 30-06 in the shape it is in and refuse to take it hunting.
I expect a reply from you on how you are going to repair this gun for me.
Will be waiting to hear from you.
