

Enclosed is a Remington 700 Serial # S6697267, 7mm Rem Mag. It has a faulty Safety on it, or trigger not sure which but this is what happens.

Randy (owner) brought this gun in very visibly shaken yesterday 10/3/10. Asked him what had happened and he said, "I almost shot my buddy." So I asked for a little more detail. He was at the range sighting it in getting ready for deer season. The gun was purchased about a year ago but hasn't been taken out of the box until this last weekend. He was shooting it and they decided to change out targets. Gun was in a rest on a table and Randy flipped on the safety to head down range. Firearm discharged missing the gentleman's leg by a matter of inches he felt the muzzle gasses hit his leg and thought he was hit. Upon inspection he was very narrowly missed. They brought the gun into me right after this. I said I would talk to you folks on Monday and see what there was to do. Just to try out the gun for myself I put the safety on worked the action and flipped off the safety and sure enough it dry fired in my hands. It doesn't do it every time, but it has done it pretty consistently. Also noted that despite numerous ammo changes he was unable to get groups of less than 5 or so inches.

I know Randy really likes his Remington's he has bought a ton of them from me. He is unhappy with this particular one. Fixed or not he isn't comfortable with this gun. He would like to know what options he has.
