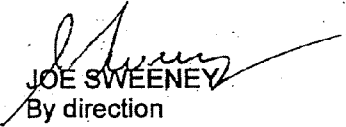

2. Request the discrepant material, NSN: 1005-01-240-2136, SER#s: G6360929 and G6451564, M24 SNIPER RIFLE, 7.62mm, Quantity: 2 EA, be returned to U.S. using the enclosed Issue Release/Receipt Document (encl 2) as authority for the return and as a source document for preparing bills of lading and other shipping papers. Ship under a Collect Commercial Bill of Lading (CCBL) via the most economic mode of transportation available to the address indicated below.

_____ Fleet and Industrial Supply Center, Ocean Terminal Division, ATTN: Code 302.1, Building CEP 201, Norfolk VA 23511-3392 for onward movement to the CONUS location indicated in block 3 of the enclosed Issue Release/Receipt Document (IRRD).

_____ Defense Distribution Depot San Joaquin, Receiving Warehouse 10, Attn: Branch Chief, 25600 South Chrisman Road, Tracy CA 95304-9150 for onward movement to the CONUS location indicated in block 3 of the enclosed Issue Release/Receipt Document (IRRD).

✓ Other: Directed Return. Air Mobility Command (AMC) Channel Airlift Authorized. Offer to the theater air clearance authority for AMC Channel Airlift from APOE to SUU. SUU Trans MVMOT Office will forward shipment to DoDAAC: CMATDX.

3. Since the enclosed IRRD contains essential data for reimbursing carriers, clearing Customs etc., one copy should be attached to outside of the shipment unit (box, skid, pallet etc.) used to return the material. One copy should also be attached to outside of the CCBL issued by the over ocean carrier for the return. One copy of the IRRD and the SDR should be placed inside the shipment unit. Do not mix individual returns in the same shipment unit; the entire unit must be forwarded intact to its final CONUS destination.
4. A credit adjustment, if applicable, will be processed upon receipt of the material at the CONUS depot specified in the enclosed IRRD. The U.S. Government will not be responsible for any transportation or related costs if material is not received by this date. Debit billing will be processed for wrong items not returned within this time limit.
