Remington Model 30 and 30 Express bolt-action rifles are <u>not</u> included in the safety modification program. These rifles were manufactured from 1921 until 1940. However, these old firearms do have a bolt-lock mechanism, which requires the safety to be placed in the "F" or "Off or Fire" position to unload and load the rifle. As with any firearm, special care must be taken during the loading and unloading process. Always keep the muzzle pointed in a safe direction. Keep the safety in the "S" or "On Safe" position at all times until you are ready to shoot. Always unload your rifle when not actually in use. Every firearm should be unloaded as soon as you are finished shooting – before taking it into your car, camp or house. Remington wants you to enjoy the shooting sports - safely!

# FIREARMS CARE AND CLEANING - BOLT ACTION RIFLES

To Clean your bolt-action rifle, Remington suggests you follow these steps

- 1. Point the firearm in a safe direction
- 2. Place the safety in the 'S' or "safe" position.
- 3. Pull the bolt to the rear. Check the chamber to make sure it is empty and not loaded. Never try to clean a loaded gun.
- 4. Open the magazine, or remove if possible. Make sure the magazine is empty.
- 5. Release the bolt stop and remove the bolt. Refer to the instruction manual.
- 6. If the firearm has a scope, cap both ends to protect the optics. Never spray cleaners or lubes on a scope.
- 7. Clean the bore following instructions in your instruction manual. We recommend that your use a plastic bolt guide to protect the trigger assembly during the bore cleaning process.
- 8. Scrub the breech with nylon breech brush moistened with a few drops of Rem Oil. For heavy fouling, use a bronze or stainless steel breech brush.
- 9. Clean the receiver and barrel exterior using patches moistened with Rem Oil.
- 10. Spray the bolt with Rem Action Cleaner, then scrub with a nylon breech brush, especially the face, locking lugs, and extractor. Finish with a light spray of Rem Oil.
- 11. After heavy or extended rifle use, remove the stock according to the manufacturer's manual, then spray the trigger assembly, the action, and receiver with a moderate amount of Rem Action cleaner. Brush off dirt and caked lubricants. Wipe clean with patches. Spray lightly with Rem Oil.
- 12. Reassemble the gun carefully and wipe all metal surface with Rem Oil. Wipe to remove fingerprints and leave a light oil film for rust prevention.

Caution: If you have any questions about the safe operating condition of any firearm, take it to a qualified gunsmith or send it to the manufacturer for service and evaluation.
