Under Part I of this project \$ _____ was authorized and preliminary designs were developed for the new center fire rifle Model XC-13 and the XP700 single shot pistol.

Indications are that most hunters in the East prefer lighter weight guns in the field for easier handling and less carrying fatigue. Interest also has increased greatly in the past few years in sidearms due to the development of new calibers such as the 357, 44 and 22 Caliber Magnums and other jet type cartridges. Varmint hunters and target shooters have shown much enthusiasm due to light weight, range, trajectory, ease of handling and accuracy of this pistol.

Models of both types of guns have been made for evaluation using wood stocks, however, further work will be necessary to develop molded stocks for ~~both models~~ ^{the pistol} and test for endurance.

The pistol and rifle will have the ~~same~~ ^{similar} bolts, receivers, sights, with nylon stocks ^{for the pistol & wood stock for the center fire rifle} and ribbed barrels. The pistol is a single shot model and the center fire rifle will have a five-shot capacity. It is planned to introduce Caliber 222 Remington Short Magnum in the pistol and 222 Remington and 308 Calibers in the center fire rifle.
