MILITARY SPECIFICATION

RIFLE, CALIBER .22, M12

This amendment forms a part of Military Specification MIL-R-1296C, dated 31 August 1964, and is mandatory for use by all Departments and Agencies of the Department of Defense.

Page 1, paragraph 2.1, under STANDANDS: Add:

"MIL-STD-130 - Identification Marking of US Military Property."

Page 2, paragraphs 3.1 and 3.2: Delete and substitute:

"3.1 3id samples...

"3.1.1 Each bidder shall furnish three rifles of the design he proposes to supply for evaluation and test to determine compliance with this specification (see 4.3.2.1, 4.3.3.1.1, and 6.3). Sample rifles shall be forwarded to an evaluation and test agency specified by the procuring activity (see 6.1). Rifles shall be representative of manufacturer's normal production.

"3.1.2 Upon award of the contract, the samples submitted by the successful bidder and approved by the evaluation and test agency will be retained for use by the contractor and the Government as manufacturing models in accordance with the manufacturing model requirements of MIL-W-13855."
