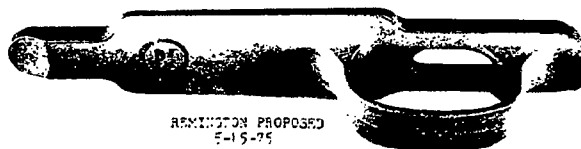

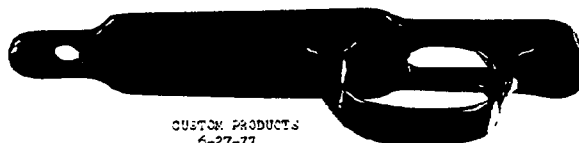

M-700 & M-600 Receivers are manufactured on same group of machines having different fixtures to produce the desired rec. It was found in reviewing M-700 & M-600 processes that rec. start out differing in length M-600 rec. blank being shorter. It was found also that the M-600 turny shape is more costly and requires an additional operation. Finally it was found thru discussion with D. Stifford, Proc. Eng. in charge at M-700 & M-600 Rec. machining, that for every M-600 Rec. produced we lose a M-700 Rec.

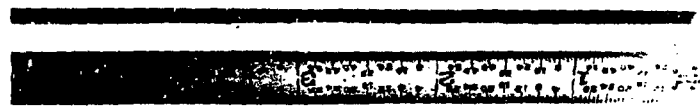

"family of guns" trigger with added shoe made by metal stamping.

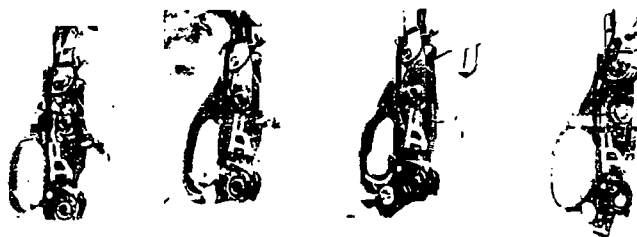
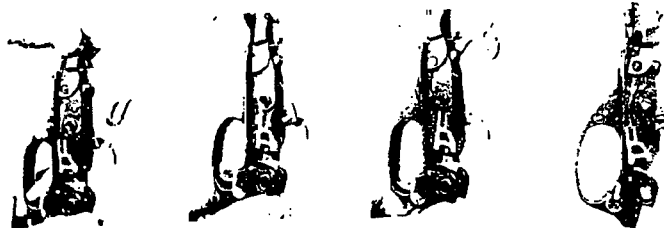
