EACH, WITH A FORCE OF 6.5 POUNDS BEING APPLIED
DIRECTLY TO THE OPERATING TAB AREA OF THE
BOLT STOP RELEASE.

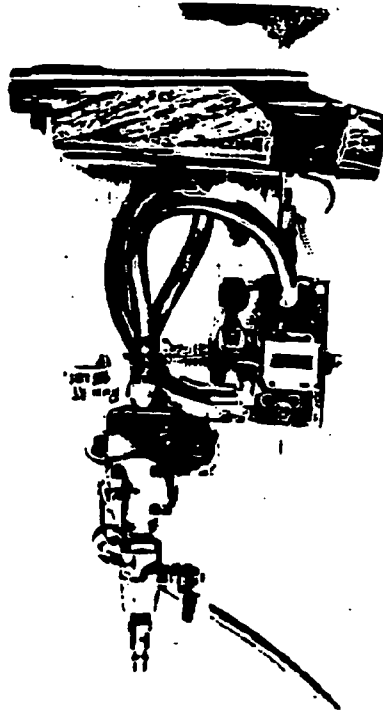
