Project Objectives:

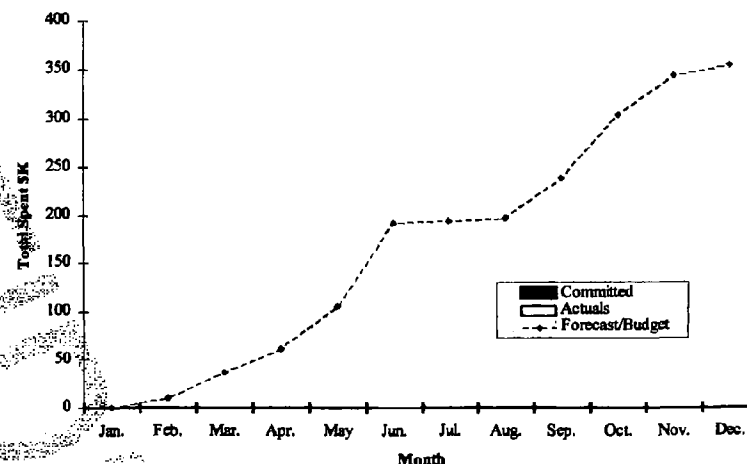
- Reduce cost to manufacture and manufacturing lead time.

- Finalizing the development schedule and product specification.
- Outside process consultant selected, contract and NDA are in place. First meeting held 11/3. Preliminary report was received 12/15. Final report due the week of March 1st.
- Investigating possible conceptual design paths to meet cost objectives.
- New concept barrel analysis was completed with excellent results. Fire control analysis is in process. Anticipated completion date is 3/10/98.
- Competitive evaluation test added to program. Six (6) guns (ea) from four (4) different manufacturers as well as ammunition to complete the test.

Areas of Concern:

- Product definition and specifications need to be finalized.

- ☐ Locking lugs and bolt body are same diameter
 - ✓ No broaching
- ☐ One piece bolt body and handle
- ☐ Easily field strippable
- ☐ Interchangeable bolt head
 - ✓ One bolt body and handle
 - ✓ Head allows .22 caliber to 12 gauge

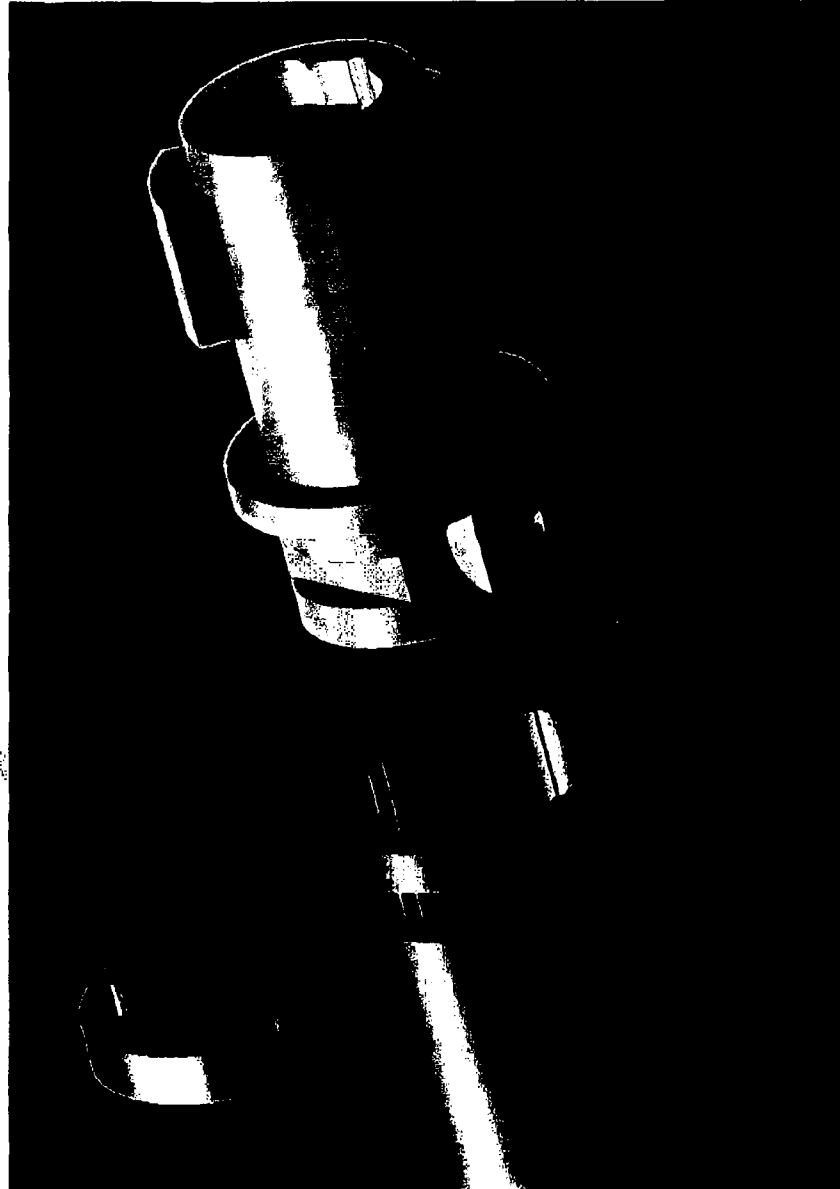

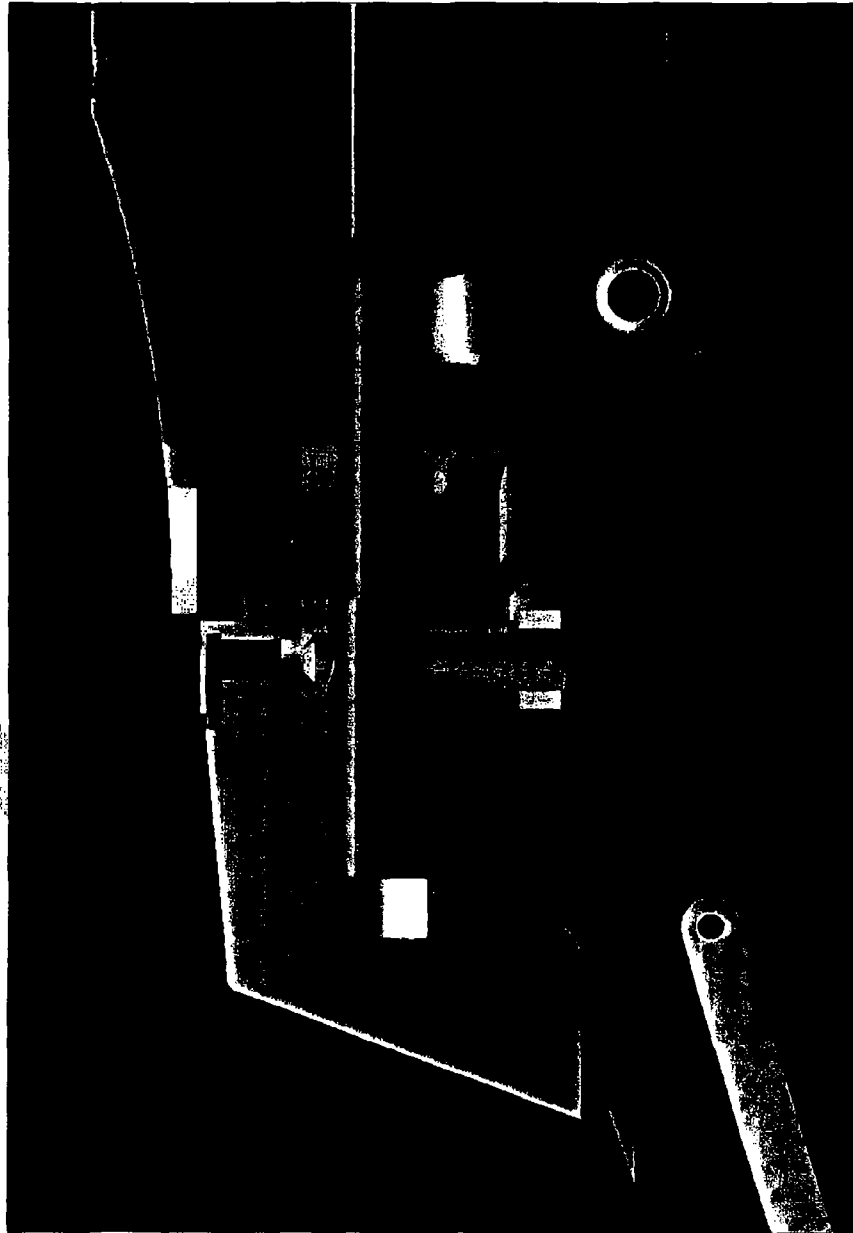

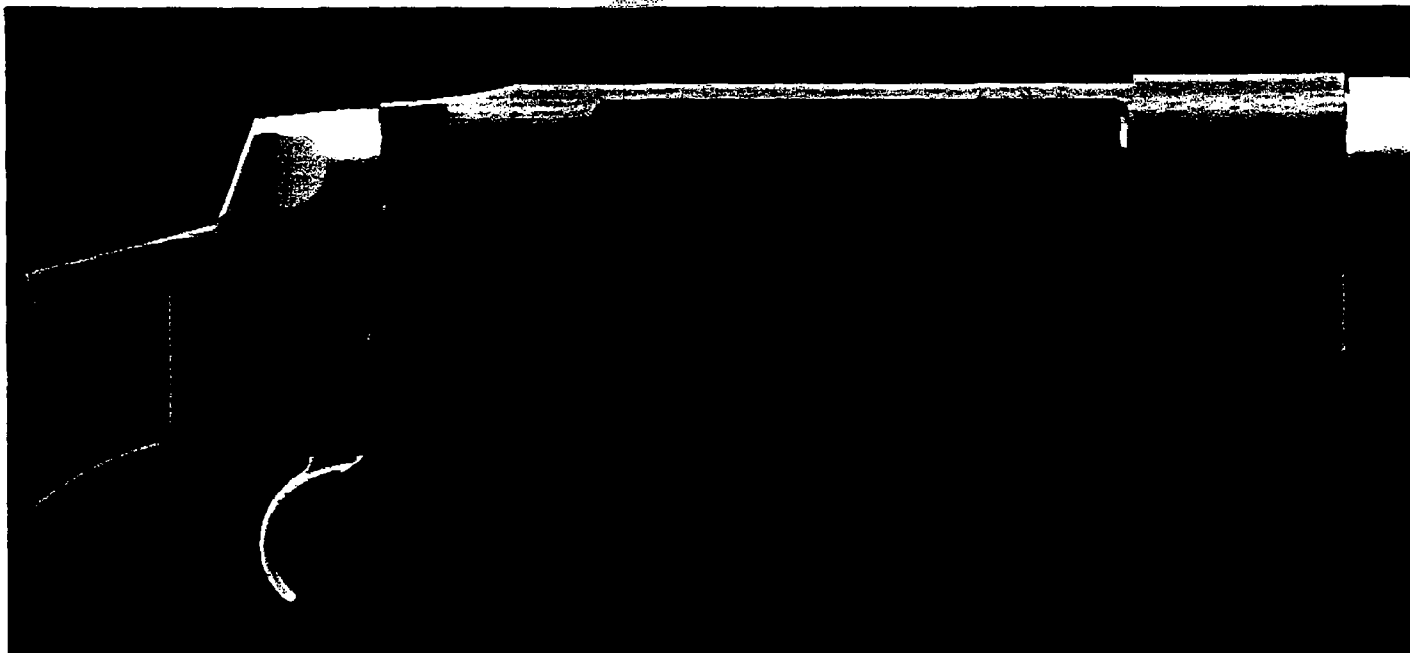

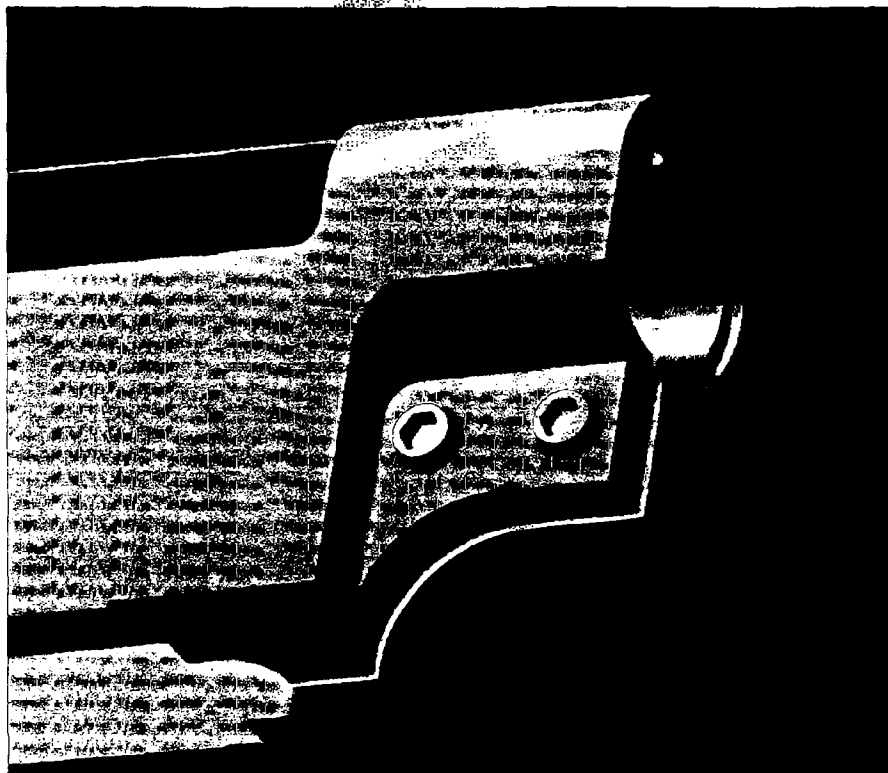

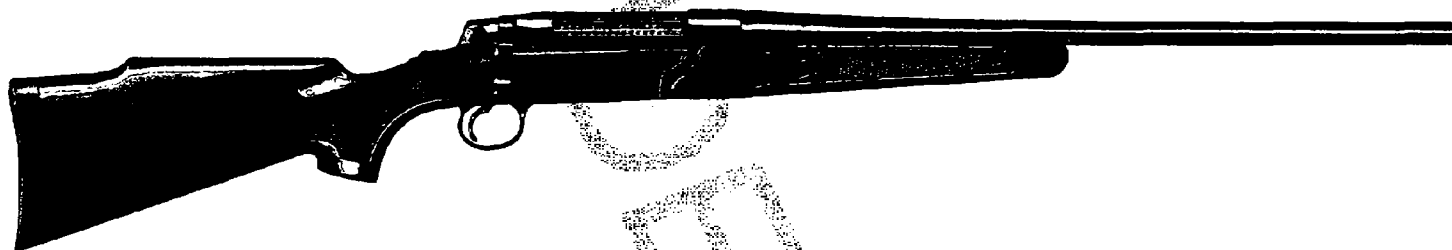

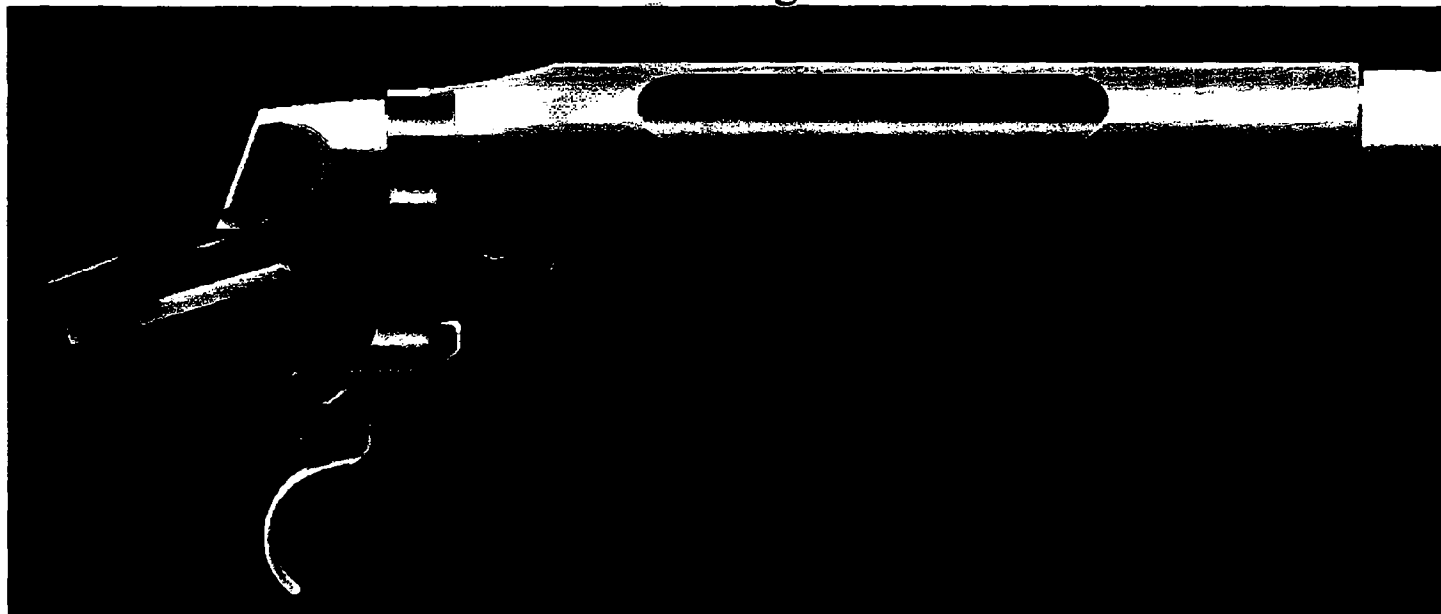

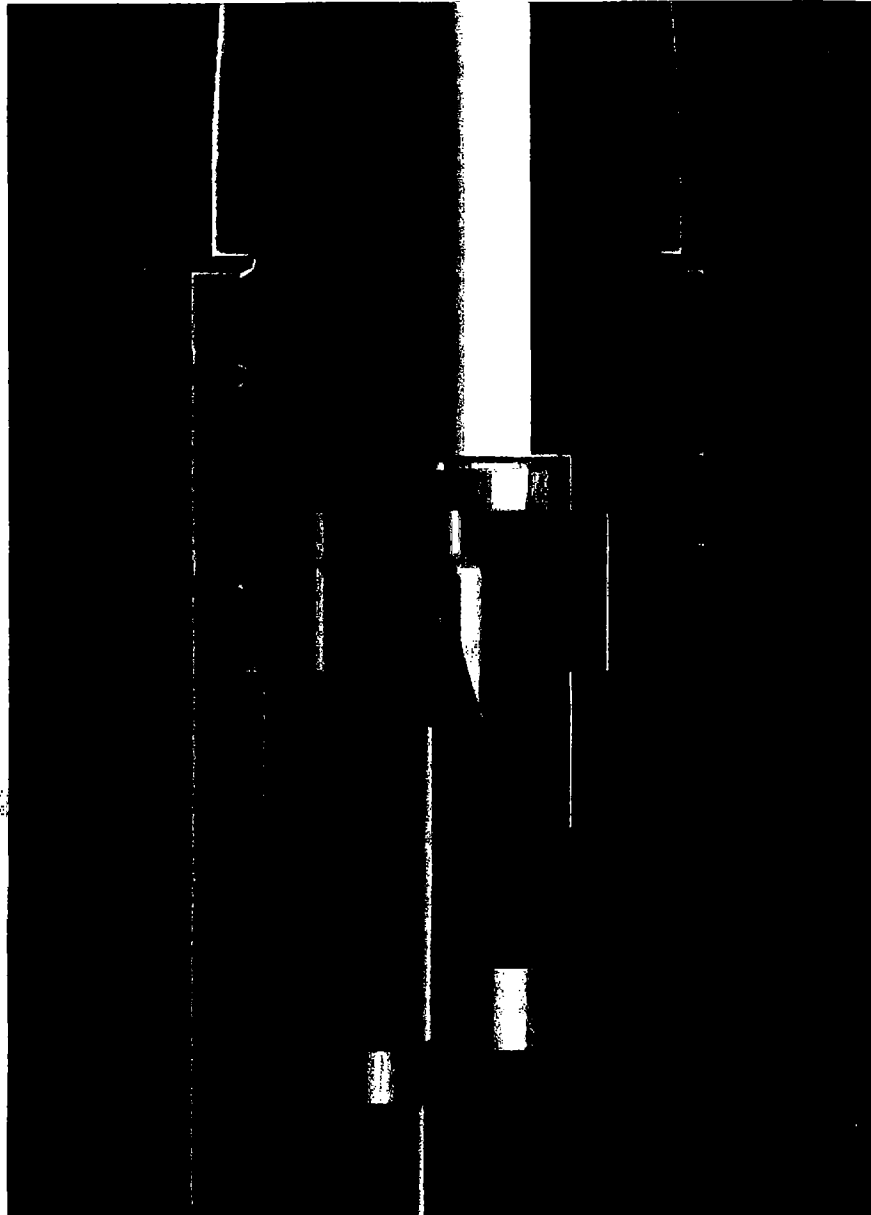

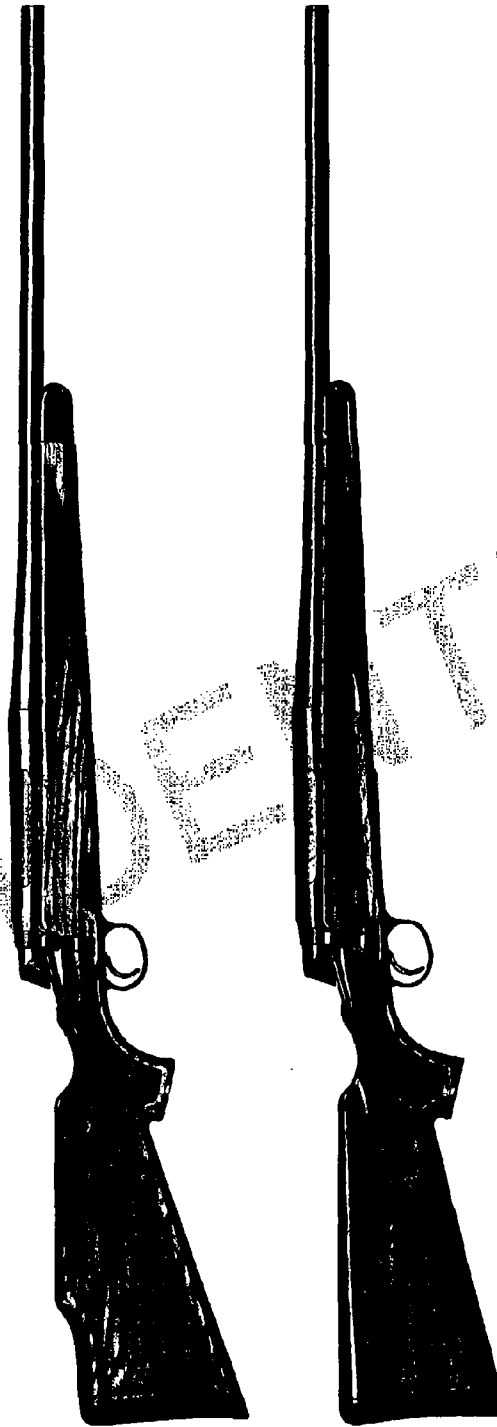
