This is designed to remind people of the existence of the bolt-lock feature and to offer customers the opportunity to modernize their products.

Based on the information you have provided, we suggest that you send your firearm to our Ilion, NY facility.

For U.S. repairs, please follow these guidelines:

3. Remove all accessories from your firearm to prevent loss or damage.

4. Enclose a letter with the firears detailing the model name or number of your firearm and serial number along with a full description of the problem. Be sure to include your full name and address (P.O. Box and Street Address), including zip code, daytime telephone number, and e-mail address.


