Good catch - 301440 is missing - I've added it in (see attached). I've added a date and time to the page footer to differentiate this PAL from the previous one.

The front and rear spacers are PM (same material as current M/700 spacers).

I don't know what the long term plans are for 301430. The parts we have today were made from 14632 (that's why I listed that P/N as a "blank"). The issue with 14632 is the dimensional control on the head

thickness is too loose, which affects hole alignment at the riveting operation.
