

- **LOCALLENT: (up to 22% discount level and orders are on a 45 day billing cycle)**
LOCAL LE NONTAX accounts are for all police departments except for the ones located in the following states: police departments located in Arkansas, Arizona, California, Hawaii, Minnesota, North Carolina, South Carolina, and Washington. If the order is equal to or greater than \$5,000.00 the customer must complete a credit application to have an **R ACCOUNT** number assigned to their agency.
- **LOCALLETAX: (up to 22% discount level and orders are on a 45 day billing cycle)**
LOCAL LE TAX accounts are for all police departments located in Arkansas, Arizona, California, Hawaii, Minnesota, North Carolina, South Carolina, and Washington. If the order is equal to or greater than \$5,000.00 the customer must complete a credit application to have an **R ACCOUNT** number assigned to their agency.
- **COUNTYLENT: (up to 22% discount level and orders are on a 45 day billing cycle)**
COUNTY LE NONTAX accounts are for all sheriff's offices/county jails except for the ones located in the following states: Arkansas, Arizona, California, Hawaii, Minnesota, North Carolina, South Carolina, and Washington. If the order is equal to or greater than \$5,000.00 the customer must complete a credit application to have an **R ACCOUNT** number assigned to their agency.
- **COUNTYLETAX: (up to 22% discount level level and orders are on a 45 day billing cycle)**
COUNTY LE TAX accounts are for all sheriff's offices/county jails located in Arkansas, Arizona, California, Hawaii, Minnesota, North Carolina, South Carolina, and Washington. If the order is equal to or greater than \$5,000.00 the customer must complete a credit application to have an **R ACCOUNT** number assigned to their agency.
- **CORRECTNT: (up to 22% discount level and orders are on a 45 day billing cycle)**
STATE NONTAX includes correctional facilities located in all states except for Arkansas, Arizona, California, Hawaii, Minnesota, (North Carolina corrections is included now, as of July 1st), South Carolina, and Washington. If the order is equal to or greater than \$5,000.00 the customer must complete a credit application to have an **R ACCOUNT** number assigned to their agency.
- **CORRECTTAX: (up to 22% discount level and orders are on a 45 day billing cycle)**
STATE TAX includes correctional facilities which will be all facilities in the following states Arkansas, Arizona, California, Hawaii, Minnesota, (North Carolina corrections is not longer taxed as of July 1st), South Carolina, and Washington. If the order is equal to or greater than \$5,000.00 the customer must complete a credit application to have an **R ACCOUNT** number assigned to their agency.
- **STLETAX: (up to 22% discount level and orders are on a 45 day billing cycle)**
STATE LE TAX accounts are all state agencies located outside the following states Arkansas, Arizona, California, Hawaii, Minnesota, North Carolina, South Carolina, and Washington. These agencies will include state police, highway patrol, state fish & wildlife agencies. If the order is equal to or greater than \$5,000.00 the customer must complete a credit application to have an **R ACCOUNT** number assigned to their agency.
- **STLENONTAX: (up to 22% discount level and orders are on a 45 day billing cycle)**
STATE LE NONTAX Are all state agencies located in Arkansas, Arizona, California,

Hawaii, Minnesota, North Carolina, South Carolina, and Washington. These agencies will include state police, highway patrol, state fish & wildlife agencies. If the order is equal to or greater than \$5,000.00 the customer must complete a credit application to have an **R ACCOUNT** number assigned to their agency.

- **LEFEDERAL: (up to 42% discount level these orders are paid by credit card)** All **LEFEDERAL** orders are tax exempt, these are for the military/government agencies. some examples of these agencies are u.s. fish & wildlife, U.S. Treasury Department, Federal Correctional Institutions, FBI, DEA, Marines, Army, Navy, Homeland Security, and the U.S. Marshalls. These are just a few of the many government/military agencies. If the order is equal to or greater than \$5,000.00 the customer must complete a credit application to have an **R ACCOUNT** number assigned to their agency.
- **LE R ACCOUNTS: (up to 42% discount level and orders are on a 45 day billing cycle)** Once an LE agency has purchased \$1000.00 worth of product on one of the above accounts they can then fill out paperwork to become an **R ACCOUNT** and receive up to a 42% discount on all orders. \$1,000.00 is the minimum amount that can be spent to open an **R ACCOUNT**. \$5,000.00 is the maximum amount that can be spent on the above account before the agency is required to open an **R ACCOUNT**.

AS OF JULY 1ST 2004 N.C. DEPT OF CORRECTIONS WILL BE EXEMPT FROM SALES TAX.

ALL THE ACCOUNTS LISTED AS A 22% DISCOUNT AUTOMATICALLY GET 22% BUT IF THEY HAVE SPENT AT LEAST \$500.00 YOU MAY CHANGE THE DISCOUNT LEVEL.
