Remington is offering a safety modification program for Bolt-action centerfire firearms made prior to 1982. To determine when your firearm was made and to see if the firearm is part of the safety modification program "click" on the model listed below and follow the directions. These firearms have a feature known as a bolt-lock safety that requires the safety to be in the 'F' or "fire" position to be unloaded. If you participate in the program your firearm will be modified to eliminate this feature.

Here are that basic program elements:

- We will clean and inspect and remove the bolt lock feature for \$20.00 plus shipping and handling.
- We will return the gun to you with a \$20.00 rebate coupon good towards the purchase of any Remington Safety product (safe, gun cabinet, hearing protection, eye protection, gun locking device).

If you own a model 700 or 40-X

To determine if your firearm has a bolt lock safety installed

- Model 700: Serial Numbers of b6349xxx and forward do not have a bolt lock installed
- Model 40-X Serial Numbers of b630xxx and forward do not have a bolt lock installed
- Call us at 877-387-6691 and we can help you determine if you have one of the firearms over the phone
- Take it to a repair center/gunsmith and have them assess whether your gun has a bolt lock feature

If it has a Bolt-Lock and you decide to participate in the program:

Once we have assessed your gun we will advise one of the following:

1. The gun is in good operating condition and we can go ahead and remove the bolt lock

If you own a model 600 or 660 or xp-100 before 1982

In 1979, Remington instituted a recall for most Model 600, 660 and XP-100 bolt-action firearms because, under certain circumstances, the safety and trigger could be manipulated in a way that could result in an accidental discharge. Under the 1979 recall program, owners of the affected firearms could return their guns for installation of a new trigger assembly at no charge. [(View a copy of the 1979 recall notice.)] Since 1979, thousands of owners of the affected firearms have participated in the recall and received new trigger assemblies.

How can you tell if your firearm was subject to the recall, and whether it was repaired as part of that program?

- All Model 600 and 660 rifles (including all Mohawk 600 rifles) except those with a serial number beginning with an "A," and all XP-100 firearms with serial numbers below 7507984 except those beginning with an "A" or "B" before the number were subject to the recall.
- Each new trigger assembly installed in firearms repaired under the recall has a "V" (approximately 1/4 inch high) stamped on the left side of the trigger below the receiver line. [(View a diagram of the placement of the "V.")] These replacement trigger assemblies included the bolt-lock feature.

How does the 1979 recall affect Remington's new bolt-lock safety program?

- If you have a Model 600, 660 or XP-100 with a bolt-lock feature, regardless of its manufacture date, it is eligible for the current bolt-lock removal offer.
- However, if your firearm was never serviced as part of the 1979 recall, a new trigger assembly without a bolt lock feature will be installed. This change will be made at no cost to you.
- If your firearm was repaired as part of the recall, or it was not subject to the recall, you may have the bolt-lock removed on the terms described below:

If it was never serviced as part of the recall in 1979, we will install a new trigger that does not have the Bolt-Lock feature installed. The service will be free to you. See service directions below

If you had the firearms serviced under the recall, then it has a bolt lock safety installed and you must decide if you want to participate in the program:
