RE: M700 TRIGGER REPLACEMENT CAMPAIGN

Remington produced approximately 3mm M700 rifles from 1962 to date. The attached sheets detail production figures and costs to replace trigger assemblies on the M700 rifles in the field.

The costs do not include any new equipment necessary to manufacture the trigger assemblies.

The return rate is estimated at 30%. All new trigger assemblies would not have a bolt lock feature. Costs are estimated at \$22.7mm

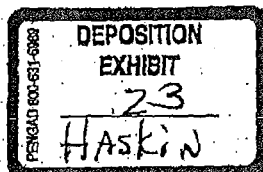
